**Terms, Conditions and Club Rules**

**IMPORTANT: ALL USERS MUST ABIDE BY THESE TERMS, CONDITIONS AND CLUB RULES AS WELL AS ANY ADDITIONAL RULES POSTED AT THE CLUB. FAILURE TO ABIDE BY THESE TERMS, CONDITIONS AND CLUB RULES (OR ANY ADDITIONAL RULES POSED AT THE CLUB) WILL RESULT IN (1) FOR THE FIRST OFFENSE, A SUSPENSION, WHICH WILL BE DETERMINED IN THE CLUB'S SOLE DISCRETION AND (2) FOR THE SECOND OFFENSE, TERMINATION OF THE ANNUAL PASS, WITH NO REFUND TO THE ANNUAL PASS HOLDER.**

General:

Passes must be paid for in full at time of purchase. (Monthly packages must be fill out the monthly charges contract)

Individual + Spouse includes a husband and wife living in the same household.

Family includes spouse and dependent child less than 21 years of age living in the same household.

All privileges are based on availability. At times, the golf course will be unavailable to pass holders due to outside events.

Certain tee times may be withheld for use by public golfers.

Discounts do not apply toward contracted or club activity.

Whitney Oaks Golf Club reserves the right to modify or discontinue these offerings at any time without advanced notice. Only a limited number of pass cards will be sold.

Club Rules:

Golf Reservation Policy:

➤ Individual Passes – entitle cardholder to reserve space for up to 4 golfers.

➤ Family Passes – entitle cardholder to reserve space for up to 8 golfers.

All Cardholders are required to register in the Golf Shop prior to start of play.

Cardholders must show their bag tag or present a valid driver's license or other identification at time of registration.

Carts are restricted to a maximum of 2 carts for 3 or 4 players or 1 cart for 1 or 2 players.

Range use is restricted to the front of the range only. (**Platinum Ultimate pass holders** are entitled to back of the driving range access, weather permitting at discretion of management)

Range balls are for range use only. Range balls may not be taken from the range for any reason, including to play on the course or to use on the range at a later time.

Golfers shall not remove cart keys from carts for any reason.

All alcohol consumed on the premises must be purchased from the Club. It is a violation of law and Club rules to bring alcohol onto the Club premises and/or to consume alcohol on the Club premises that is not purchased from the Club.

Golf Cart Rental and Release Agreement

I shall use proper judgment and caution at all times when operating and/or renting a golf cart on or about the golf course ("Golf Cart Use") at Whitney Oaks Golf Club (the "Club") and agree that the Club's owner, operator, employees, agents, contractors and representatives ("Club Parties") shall not assume nor be liable for any bodily injury, property damage, claim, liability, costs or expenses, including attorneys fees (collectively "Claims") caused to or incurred by the Club or any individual resulting from Golf Cart Use. I shall assume all risk of my Golf Cart Use and shall indemnify, defend and hold Club Parties harmless from any and all Claims resulting or arising, directly or indirectly, from such Golf Cart Use and shall immediately report any Claims directly to the Club's General Manager. My Golf Cart Use shall be in compliance with all applicable laws, all rules that may be posted in the carts and on the golf course, and the following:

- o Persons operating golf carts must have a valid auto mobile driver's license, be familiar with the use and proper operation of a golf cart, and shall not be under the influence of drugs or alcohol.
- o Golf carts are restricted to use on the golf course and practice areas. No golf carts owned by the Club shall be removed from the Club facilities at any time.
- o No more than two persons and two sets of golf clubs per cart are allowed. All occupants must be seated entirely inside the cart during its operation and hold on at all times. No one is permitted to sit on the back of the cart or stand on the bumper.
- o Golf carts shall remain on cart paths on required holes and in designated areas on those holes that allow cart traffic. Drivers must observe and obey all signs, stakes, roped-off areas, and other markers used to guide carts. Golf carts shall not be driven or parked within thirty feet of any tee, bunker, green, or hazard, except on cart paths. When driving golf carts on fairways, care should be taken to avoid soft areas and sprinkler heads. Golf carts shall be driven slowly straight up and down slopes and in turns and extra care shall be taken when driving in reverse, congested or wet areas, and on hilly or loose terrain. The parking brake must be set before leaving the golf cart.
- o Violation of these golf cart rules may result in immediate suspension of playing privileges and ejection from the golf course.
